You are hereby informed that your personal data is processed by the in the case of:

- your request for presenting our offer. Legal basis: undertaking actions upon request of the data subject prior to concluding an Agreement (Article 6 (1)(b) GDPR);
- submission of the order by the Buyer in order to perform of the contract of sale. Legal basis: indispensability for the contract of sale performance (Article 6(1)(b) GDPR).

Your personal data is processed as long as it is necessary for the contract performance as well as upon termination of the contract in order to:

- pursue claims in connection with the performance of the contract;
- perform the obligations under the law , in particular those of tax and accounting;
- prevent abuse or fraudulent conduct;
- statistical and archival purposes;

for the same period as the duration of our liability for the delivered goods / provided services. Unless a specific provision establishes otherwise, a limitation period is 6 years and for the claims for periodical performance and those connected with conducting business activity – 3 years.

For purpose of accountability, i.e. to prove the compliance with provisions connected with processing perosnal data , personal data will be kept for the period during which the Controller is obliged to keep the data or the documents containing the data in order to docuemnt the compliance with legal requirements to allow public authorities to verify the fulfillment of the obligations.

Your personal data is transmitted to the services providers that we used in order to implement the agreement concluded.

- The Processors that act solely at our request : hosting services providers, accounting services, couriers, co-operating companies.
- The Controllers that do not act solely at our request and establish on their own the purposes and manners of the use of your personal data. They provide electronic payments services and banking services.
